LATE ARRIVALS/UNAVAILABILITY: All persons for whom makeup will be done need to
be present prior to their scheduled time so that their session may begin promptly. Regardless of when a person arrives, each person's session will end at its specified end time, meaning that the makeup artist may not have time to do a complete application for late arrivals. When a Client or a member of their party arrives late, the makeup artist will use her best efforts to achieve the optimal results in the time remaining. If the Client desires and the makeup artist's schedule permits, the makeup artist may agree, at her sole discretion, to do a full application. If any person is not available at all for an appointed booking time, his or her makeup session will be cancelled. The Client will not be entitled to a refund of any deposit paid for that application.
CANCELLATION/DEPOSITS: The Client may seek a return of any deposit paid at any time prior to the passage of three (3) days from its payment. All deposits become non-refundable after three (3) days. In addition, deposits and scheduled dates and times are Client-specific and are non-transferable. If the makeup artist is forced to cancel the contract at any time, or is unable to perform her duties for any reason, any deposit paid will be refunded in full by check within two (2) weeks from the date of cancellation Initial
TRAVEL FEE: A mileage fee of \$15.00 will be charged for every 20 minutes of travel time both to from the location (based on GPS). The amount of this fee will be determined prior to the signing of the contract Initial
LIABILITY: All brushes and makeup products are kept sanitary and are sanitized between every makeup application. Makeup products used are hypoallergenic. Any skin condition should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client hereby releases the makeup artist from any liability for any skin complications due to allergic reactions Initial
PAYMENT: The balance of the contract price is due on the day of the event as one payment - no exceptions.
