**BOOKING POLICIES, TERMS & CONDITIONS**

**BOOKING TIMES:** Each service requires a certain length of time to be completed. The Makeup Artist will discuss the Client’s needs and they will determine how much time to allow for each service. All services for the same event must be at the same location and consecutive in time (no gaps in between), because the Professional(s) may have other commitments. The contract will contain a specific start and end time for each service. These times will be discussed when the reservation is made. To book the event, in addition to any other requirements, the Client will be required to indicate their approval of the times by initialing the Term Sheet where indicated.

**SERVICE LOCATION AND REQUIREMENTS:** Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the Professional(s) need to complete the makeup. A “set up” table/work area needs to be made available for the Professional(s) at said location. Working electrical outlets must also be made available for use by Professional(s). Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. A chair is requested but not necessary. \_\_\_\_\_ Initial

**BOOKINGS:** To secure a date, a signed contract is required, together with a deposit of 50% of the contract price. Date of event will only be held for 2 weeks post Bridal Trial. The deposit is due at the time of signing. Dates and times will not be reserved until both a signed contract and deposit have been received. \_\_\_\_\_ Initial

**ADDITIONAL WORK:** While the Makeup Artist will make every effort to accommodate additional requests not covered by the contract, any additional makeup that may arise after the contract has been signed will only be performed at the discretion of the Artists. Such additional requests may incur additional charges that will be discussed with the Client prior to being performed. \_\_\_\_\_ Initial

**LATE ARRIVALS/UNAVAILABILITY:** All persons for whom will be done, need to be present prior to their scheduled time so that their session may begin promptly. Regardless of when a person arrives, each person's session will end at its specified end time, meaning that the Makeup Artist may not have time to do a complete application for late arrivals. When a Client or a member of their party arrives late, the Makeup Artist will use their best efforts to achieve the optimal results in the time remaining. If the Client desires and the Stylist's schedule permits, they may agree, at their sole discretion, to do a full application. If any person is not available at all for an appointed booking time, his or her service will be cancelled. The Client will not be entitled to a refund of any deposit paid for that application. \_\_\_\_\_ Initial

**CANCELLATION/DEPOSITS:** The Client may seek a return of any deposit paid at any time prior to the passage of three (3) days from its payment. All deposits become non-refundable after three (3) days. In addition, deposits and scheduled dates and times are Client-specific and are non-transferable. If the Makeup Artist is forced to cancel the contract at any time, or is unable to perform her duties for any reason, any deposit paid will be refunded in full by check within two (2) weeks from the date of cancellation. \_\_\_\_\_ Initial

**TRAVEL FEE:** A mileage fee of \$25.00 will be charged for every 20 minutes of travel time both to and from the location (based on GPS). The amount of this fee will be determined prior to the signing of the contract. \_\_\_\_\_ Initial

**LIABILITY:** All brushes and makeup products are kept sanitary and are sanitized between every service. Makeup products used are hypoallergenic. Any skin condition should be reported by the client to the Makeup Artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client hereby releases the Makeup Artist from any liability for any skin complications due to allergic reactions. \_\_\_\_\_ Initial

**PAYMENT:** The balance of the contract price is due on the day of the event as one payment - no exceptions. The person(s) responsible for the entire balance of payment is the person(s) who has signed the booking contract. Acceptable forms of payment are: cash, venmo, or check made payable to **Lashing Out Studio, LLC**. \_\_\_\_\_ Initial

**SEVERABILITY:** If any provision or provisions of this Contract shall be held to be invalid, illegal, unenforceable or in conflict with any of the law(s) of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby. \_\_\_\_\_ Initial

- Flower Girl \$30 (same for both off site and in studio)**
- Junior Bridesmaid \$75 (same for both off site and in studio)**
- Bridal On Site Touch Ups \$175/Hr**
- Travel Fees \$25/20mins of Travel (to & from)**
